It is my desire that each of you will continue to fast and pray for the success of this annual meeting.

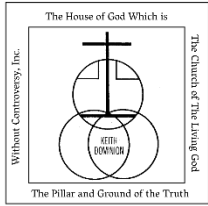

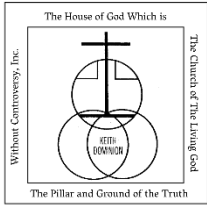

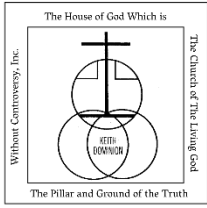
**ALL CHURCHES WITHIN THE DIOCESE ARE TO MEET ON** Saturday, August 3, 2024, at 11:00 AM.

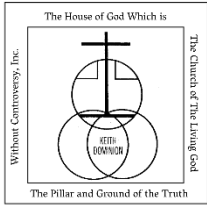

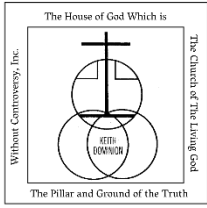

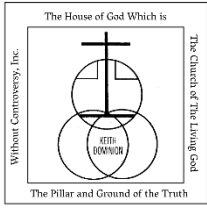
