

Re: NC Diocese Communications for Out of Diocese or Organization, Person or Group

"For I the LORD thy God will hold thy right hand, saying unto thee, Fear not; I will help thee." Isaiah 41:13.

As we continue to operate in unity and the spirit of excellence, it is my desire that we continue to be a beacon light for the world to see and come home. Is it not written, "Ye are the light of the world. A city that is set on an hill cannot be hid. Neither do men light a candle, and put it under a bushel, but on a candlestick; and it giveth light unto all that are in the house. Let your light so shine before men, that they may see your good works, and glorify your Father which is in heaven." Matthew 5:14-16.

PART I

If a State or Local Department, Auxiliary or Local Church desires to invite any person or group, **who are not** members of The House of God Church, Inc., Keith Dominion – North Carolina Diocese, or members of another diocese (this includes preachers/ teachers, singers, etc.) MUST:

- 1. notify the Office of the Jurisdictional Prelate, by email, of the desire to invite the person or group. It is imperative that the person making the request include all pertinent information (date/ time of the event, sponsor, location, etc.)
- 2. receive a written approval from the Office of the Jurisdictional Prelate, prior to contacting the person or group. Also, before any advertisement is published, via email, text, printed ad/ flyer or social media. This has been a long-standing practice within this church for over 40 years. See also, NC Diocese Advertisement Protocols For All NCD Churches & Departments.

Once approval has been granted from the Office of the North Carolina Jurisdictional Prelate, in writing, the person making the request must: (a) contact the State Bishop or Presiding State Elder, where applicable, of the diocese of the person or group for written permission to contact the Pastor for approval of the person or group. (b) contact the Pastor, where applicable, for written person to contact the person or group. If approval has been granted by the State Bishop or Presiding State Elder and Pastor, in writing, the person making the request can then (c) contact the person or group.
