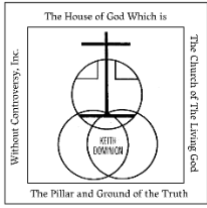
PART II:

86th Holy Gathering (A State Assembly Event)... March 5-8, 2026 - Raleigh, NC

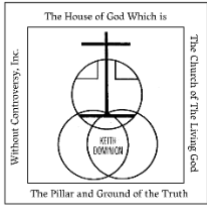

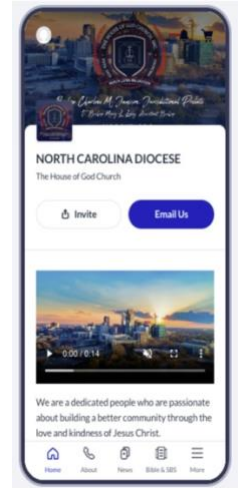
